Members are bound by the Club Rules and the Byelaws as adopted from time to time. Applicants may ask for a copy of these prior to completion of this form. Contact details are on the front cover of this application form.

### **Extracts from the Club Rules:**

#### Rule 9. (b)

Family Membership; (1) and Family Social Membership (Full) (3) subscription includes for the elected Member, their partner and members of their family under the age of 18 years or 25 years whilst remaining in full time education. The full name of the partner shall be included in the official Membership List which is open to scrutiny by all Members. Any partner not so named will be subject to rules applying to visitors. Family Membership grades are designed for married couples with or without children. In the context of such Membership the description of partner will be strictly interpreted to mean husband and wife, whether legally married or established cohabiting adults (e.g. common law husband and wife).

#### Rule 9. (c)

Senior Membership; (2) and Social Membership (5) covers individuals. A partner not being a Member in his or her own right would be classified as a visitor. Attention is drawn to the Bye-Law No. 3 restricting the number of visits permitted during 1 year.

#### Rule 9. (d)

Associate; A Family Member or Senior Social Member of the SMYC of at least 3 years standing may also apply for Associate Membership (6) if, having moved away from the area, he no longer moors his boat on Club waters, and has joined another recognized Yacht Club or Association. A current Membership Card must be produced as in the preceding paragraph.

#### Rule 9. (e)

Visiting Members of another Yacht Club, which is affiliated, to the Royal Yachting Association shall be entitled to use the facilities of the Club.

#### Rule 9. (f)

Crew Member; Having attained the age of 18 years or 25 years as the case may be under rule 9 (b), children of existing Members may be admitted to a new class of Membership with no voting rights, namely -Crew Memberø(8).

#### Rule 9. (g)

Senior Social; (7) (non boating members aged 65 and over, Ladies over 60).

### Rule 9. (h)

Family Social Membership (Restricted); Restricted to person or persons who do not have a boat in the UK waters but who may make use of Club premises for the benefit of the club as a whole, (a) Any holders of this membership may not hold committee positions or vote at an AGM but can however sit on sub-committees. (b) They can own a caravan. (c) this to be restricted to no more than 15% of the total Club membership.

#### Rule 10 (a)

Subscriptions are due and payable on 1st January in each year for the ensuing 12 calendar months; any Member elected after 1st September shall not be liable for a second subscription until the end of the following year.

## Rule 10 (b)

On election of a new member, the Hon. Secretary shall notify the same to them and request they remit the amount of their entrance fee and their subscription. No newly elected Member shall enjoy any privileges of the Club, moor a boat on Club waters or be allowed to vote, until the entrance fee and subscription have been paid and in the case of boat owners, mooring fees have been paid in full.

# Rule 10. (c)

Should a newly elected Member not have paid their fees within one month, their election shall be considered void unless satisfactory explanation as to the delay can be given to the Committee.
